## *Ultimate Giveaway Official Rules*

1. How to enter/winner selection: All brides who are in attendance and present at the time of the giveaway are eligible to win. When you check in at the Bridal Expo at the Jacksonville Commons Recreation Center, 100 Recreation Dr, Jacksonville, NC you will be given a registration form as entry. You must be present to win. The Grand Prize "The Ultimate Giveaway" will be awarded at 3:00 pm and announced at the event.
2. Grand Prize: One (1) Ultimate Giveaway (valued at no more than \$2000) will be awarded. The winner will be presented with the 2026 Engaged Onslow Vendors List. The winner can use one or more 2026 Engaged Onslow Vendor(s) of her choice spending up to \$2000. As the winner makes contact with the vendors of her choice, she is to contact the Engaged Onslow Representative and provide her choice of vendor(s) selected. It will be up to the winner to inform the Engaged Onslow Representative of each vendors she chooses and the value of the invoice to be paid.
